



State of Georgia Announces New Statewide Contract for All Terrain Vehicles (ATV), Utility Vehicles (UTV) and Golf Carts

The Georgia Department of Administrative Services, State Purchasing Division, has established a Statewide Contract for **All Terrain Vehicles (ATV), Utility Vehicles (UTV) and Golf Carts, with Options, Parts, and Accessories for all three categories**, with the following suppliers:

This is a **mandatory contract** available for use by all state, city and county public entities within the State of Georgia.

The purpose of this contract is to provide authorized users with vehicles and related options, parts and accessories in three (3) product categories: (1) All Terrain Vehicles (ATVs), (2) Utility Terrain Vehicles (UTVs), and (3) Golf Carts.

Key benefits of the contract include:

- Golf carts: 40.66% off manufacturer catalog prices; 11.85 % off for range cars and 25% discount on parts, options and accessories
- Utility Vehicles (UTV): 35% off manufacturer catalog prices; 30% discount on parts, options and accessories
- All Terrain Vehicles (ATV): 9% off manufacturer catalog prices; 10% discount on parts, options and accessories
- Variety of Product: Suppliers' entire catalog is available for vehicles and parts within the awarded categories
- Ability to customize with the parts, options and accessories on contract
- Contract management support at the state level

The contract start date is **January 14, 2013** and will be hosted in a phased approach in Team Georgia Marketplace™. Phase I begins on January 14, 2013, and the contract will be a "static" document in Team Georgia Marketplace™, giving supplier contacts and ordering information. Phase II will follow with a fully integrated application in Team Georgia Marketplace™, in a hosted, punch out or hybrid capacity. The timeframe for Phase II will be disseminated in a separate communication.
