Special Terms and Conditions:

Item number #2 on the attached item schedule is used predominately by the Georgia Department of Corrections. This department stocks and distributes this item therefore they normally order approximately 3,000 cases per quarter. This RFQ required the awarded contractor deliver within ten (10) days of receipt of order, except for Item #2. The delivery days for this item cannot exceed thirty (30) days. Bidder indicated on the RFQ that Item #2 would be shipped within thirty (30) days after receipt of Purchase Order.

Price:

The prices set out in the attached Request for Quotation shall be firm for a period of twelve (12) months. Only one (1) increase will be allowed during the two (2) years contract period. Increase will not exceed the percentage increase as shown in the PPI (Producer Price Index) for the previous twelve (12) month period and must be substantiated by documentation justifying the increase. State Purchasing must be notified at least 30 days in advance prior to any price change and contractor must have approval before such change may be effective.

Freight:

The goods shall be delivered F.O.B. the destination shown on each Field Purchase Order for all orders totaling \$300.00 or more for shipment to a single destination. Orders for less than \$300.00 to a single destination may be shipped prepaid with transportation charges added to the invoice as a separate item. Transportation charges for orders totaling more than \$300.00 may be cause for a rejection of the bid.

Note: In instances where order is for \$300.00 or more to one destination but contractor makes partial shipment(s) or order, shipments shall be made F.O.B destination with no transportation charges added.

Guarantees:

All customary guarantees for workmanship, quality and performance specified by the manufacturer for any and all items shall apply to the items offered under this proposal.
