#### **Fuel Surcharge**

UPS uses an index-based surcharge that is adjusted monthly. Changes to the surcharge will be effective the first Monday of each month and posted approximately two weeks prior to the effective date. For your billing convenience, we will also post a 90-day surcharge history. The surcharge will be based on the National U.S.

Average on Highway Diesel Fuel Prices reported by the U.S. Department of Energy for the month that is two months prior to the adjustment. (UPS research has shown this index is highly correlated with other major fuel price indices worldwide.) For example the surcharge for January 2006 is based on the November 2005 National U.S. Average On Highway Diesel Fuel Price.
